4. EXAMINATION INFORMATION

The Phase 2 Examinations comprise of written examinations in Pathology, Clinical Radiology Examinations (MCQ Examination and the Case Reporting Examination) and the Objective Structured Clinical Examination in Radiology (OSCER).

Candidates who have previously sat and been unsuccessful in any component of the Part 2 Examinations must sit the new Phase 2 Examinations.

Candidates that have previously failed the Pathology Viva apply to sit the Supplementary Pathology Viva.

For trainees, all Phase 2 Examinations must be successfully completed by the end of Phase 2 of training. IMGs required to undertake the Phase 2 Examinations, must successfully complete all examinations within the specified timeframe to meet the Specialist Recognition pathway requirements.

Transitioning Trainees and IMGs

All trainees who have completed 24 months or more of accredited training as of Feb 2022 sit with the old Part 2 Examination rules, irrespective of the examination format. All trainees who have completed less than 24 months training as at Feb 2022 sit under the new Phase 2 Examination requirements and must pass the written examinations before presenting to the OSCERs.

IMGs who commenced sitting the examinations prior to Sitting 1, 2023 will sit the examinations under the old Part 2 Examination rules. IMGs who commence sitting (for the first time) from Sitting 1, 2023 will sit with the new examination rules.

Old rules - Candidates are able to sit the OSCER examinations without having to have first passed the written examinations within four consecutive opportunities. Not sitting at the next consecutive examination sitting is considered a missed opportunity.

Please note - All transitioning candidates will be entitled to an additional consecutive opportunity as outlined in the transition documents within the Clinical Radiology Training Program Handbook.

New Examination Requirements

Written Examinations

Candidates may sit the Phase 2 Written Examinations together or independent of each other. The written examinations are delivered online using proctoring. Candidates are unable to sit in their training or practice site and must make their own alternate arrangements. More information about proctoring and the technological requirements are available on the RANZCR [Website](#).

OSCER Examinations

The OSCER Examinations are delivered using an electronic system with all candidates in one location and examiners in another location. There are seven OSCER Stations across seven topic areas: Abdominal, Breast, Musculoskeletal, Neuroradiology/Head and Neck, Obstetrics and Gynaecology, Paediatrics, and Thoracic and Cardiovascular. Candidates sitting the OSCER Examinations for the first time must still all seven Stations.

Once a candidate has commenced sitting the examinations, not sitting at the next consecutive examination sitting is considered a missed opportunity.

As a candidate commencing the Phase 2 Examinations in Sitting 1, 2023 I understand that I have up to a maximum of six consecutive opportunities from the commencement of my first sitting, with a maximum of three consecutive opportunities for each exam:|

1. Pathology Examination – maximum three opportunities
2. Clinical Radiology Examinations – maximum three opportunities
3. OSCERs – maximum three opportunities

Or as a transitioning candidate I understand that I have a maximum of four plus one consecutive opportunities from the commencement of my first sitting.



The maximum number of exam opportunities is irrespective of my Full Time Equivalent (FTE) status; and number of examinations sat at an opportunity. Not sitting an examination opportunity will be recorded as a missed opportunity.
