The Part 1 examinations have been retired and new Phase 1 examinations commence from 2022. New trainees must sit and pass the Phase 1 examinations within 24 months of commencement of training. Trainees may sit the examinations together or independently of each other. Trainees who have failed one or two components of Part 1 anatomy examinations (Paper 1 and Paper 2) must sit the new Phase 1 anatomy examination in its entirety. Trainees who have failed one or two components of Part 1 AIT examinations (Paper 1 and Paper 2) must sit the new Phase 1 AIT examination in its entirety.
